**UPON APPLICATIONS** by Donna Frances Dahm and Robert Pius Plowman (joint), the Canadian Civil Liberties Association, the British Columbia Civil Liberties Association and the David Asper Centre for Constitutional Rights for leave to intervene in the above appeal;

**AND THE MATERIAL FILED** having been read;

**IT IS HEREBY ORDERED THAT:**

The motions for leave to intervene of the Canadian Civil Liberties Association, the British Columbia Civil Liberties Association and the David Asper Centre for Constitutional Rights are granted and the said three (3) interveners or groups of interveners shall be entitled to each serve and file a factum not exceeding ten (10) pages in length on or before December 23, 2015.


The motion for leave to intervene by Donna Frances Dahm and Robert Pius Plowman (joint) is dismissed.

The requests to present oral argument are deferred to a date following receipt and consideration of the written arguments of the parties and the interveners.

**The interveners are not entitled to raise new issues or to adduce further evidence or otherwise to supplement the record of the parties.**

Pursuant to Rule 59(1)(a) of the *Rules of the Supreme Court of Canada*, the interveners shall pay to the appellant and respondent any additional disbursements occasioned to the appellant and respondent by their intervention.

The respondent is permitted to serve and file a single factum not exceeding ten (10) pages in reply to these interventions on or before January 7, 2016.
